1. Important

1.1 Safety precautions and maintenance

Warnings

Read and follow these instructions when connecting and using your USB docking stand.

Operation

- Please keep your USB docking stand out of direct sunlight, very strong bright lights and away from any other heat source. Lengthy exposure to this type of environment may result in discoloration and damage to your USB docking stand.
- Remove any object that could fall into the connection ports or prevent proper cooling of your USB docking stand's electronics.
- When positioning your USB docking stand, make sure the power plug and outlet are easily accessible.
- Turn off your USB docking stand by detaching the power cable or DC power cord.

- Please use approved power cord provided by Philips at all times. If your power cord is missing, please contact with your local service center. (Please refer to Customer Care Consumer Information Center)

2 Install the USB docking stand to your monitor

1. Place the monitor face down on a smooth surface. Pay attention not to scratch or damage the screen.



2. Snap in the base in the VESA mount area. Use a screwdriver to tighten the four screws.

3. USB docking stand

3.1 What is it?

Philips USB docking stand connects your notebook/PC to the display as well as external peripherals. It turns one USB port into USB/video connectors, so that you could access to all of your peripherals, including USB device, keyboard & mouse, speakers, SD card and even internet by LAN.

With this stand there's no need to purchase a new dock with future notebook purchases. It unclutters your desk, to give you more space for a more productive work area.

With the flexibility of mounting existing 19'' up to 28'' monitors with VESA mounting standard, Philips USB docking stand is also able to expand your workspace by adding additional monitors. You can also connect HDMI/DP port to your HDMI/DP monitor or USB port to DisplayLink™ USB monitor. With Windows OS, it can be connected up to 6 displays, not including the notebook display. With Mac OS, it can be connected up to 4 displays, not including the notebook display.

- 1. Remove fuse cover and fuse.
- 2. Fit new fuse which should be a BS 1362 5A,A.S.T.A. or BSI approved type.
- 3. Retit the fuse cover.

If the fitted plug is not suitable for your socket outlets, it should be cut off and an appropriate 3-pin plug fitted in its place.

If the mains plug contains a fuse, this should have a value of 5A. If a plug without a fuse is used, the fuse at the distribution board should not be greater than 5A.

NOTE: The severed plug must be destroyed to avoid a possible shock hazard should it be inserted into a 13A socket elsewhere.



How to connect a plug

The wires in the mains lead are coloured in accordance with the following code:

BLUE -"NEUTRAL"("N") BROWN -"LIVE"("L") GREEN&YELLOW -"EARTH"("E")

- 1. The GREEN&YELLOW wire must be connected to the terminal in the plug which is marked with the letter "E" or by the Earth symbol or coloured GREEN or GREEN&YELLOW.
- The BLUE wire must be connected to the terminal which is marked with the letter "N" or coloured BLACK.
- 3. The BROWN wire must be connected to the terminal which is marked with the letter "L" or coloured RED.

Before replacing the plug cover, make certain that the cord grip is clamped over the sheath of the lead - not simply over the three wires.

7.1 Troubleshooting

This page deals with problems that can be corrected by a user. If the problem still persists after you have tried these solutions, contact Philips customer service representative.

1 Common Problems

There is no video on the monitor attached to the dock.

- Check the video connection cables to the dock.
- Unplug from the power supply, wait 10 seconds, and then re-connect to the power supply.

The video on the attached monitor is distorted or corrupted.

- Check video connection cables.
- Check the video resolution under Control Panel > All Control Panel Items > Display> Change Display Setting.

The video on the attached monitor is not displaying in extended mode.

Change the settings by either:

- Configuring under Control Panel > All Control Panel Items > Display > Change Display Setting.
- Switch by cycling the "Windows Key 灯+P.

The audio connectors are not functioning.

 Check the setting under Control Panel > All Control Panel Items > Sound to make sure the USB Audio device is available and set to default. Right click to show all available options.

HDCP content is not able to display on the attached monitor.

Check that the attached monitor is HDCP compliant.

DisplayLink driver not able to install.

Get the driver by either:

- Downloading the latest driver from the DisplayLink website at www.displaylink.com/support.
- Connect to Windows Update with Docking stand. (by using Wi-Fi or Ethernet port of the notebook)

Notebook failed to boot with dock connected.

 Remove all USB devices connected to the dock; some unqualified boot devices may cause lock up at boot screen.

No CD drive and no Internet access for downloading the driver.

- Get an external optical drive to load the driver from the CD.
- Download the driver from http://www. displaylink.com/support/downloads.php to a USB flash drive and run the setup.

Screen says



- Make sure the monitor cable is properly connected to your USB docking stand. (Also refer to the Quick Start Guide).
- Check to see if the monitor cable has bent pins.
- Make sure the USB docking stand is turned on.

Visible signs of smoke or sparks
