# 1. Important

This electronic user's guide is intended for anyone who uses the Philips monitor. Take time to read this user manual before you use your monitor. It contains important information and notes regarding operating your monitor.

The Philips guarantee applies provided the product is handled properly for its intended use, in accordance with its operating instructions and upon presentation of the original invoice or cash receipt, indicating the date of purchase, dealer's name and model and production number of the product.

# 1.1 Safety precautions and maintenance

#### Warnings

Use of controls, adjustments or procedures other than those specified in this documentation may result in exposure to shock, electrical hazards and/or mechanical hazards.

Read and follow these instructions when connecting and using your computer monitor.

#### Operation

- Please Keep the monitor out of direct sunlight, very strong bright lights and away from any other heat source. Lengthy exposure to this type of environment may result in discoloration and damage to the monitor.
- Remove any object that could fall into ventilation holes or prevent proper cooling of the monitor's electronics.
- Do not block the ventilation holes on the cabinet.
- When positioning the monitor, make sure the power plug and outlet are easily accessible.
- If turning off the monitor by detaching the power cable or DC power cord, wait for 6

seconds before attaching the power cable or DC power cord for normal operation.

- Please use approved power cord provided by Philips all the time. If your power cord is missing, please contact with your local service center. (Please refer to Customer Care Consumer Information Center)
- Do not subject the monitor to severe vibration or high impact conditions during operation.
- Do not knock or drop the monitor during operation or transportation.

#### Maintenance

- To protect your monitor from possible damage, do not put excessive pressure on the monitor panel. When moving your monitor, grasp the frame to lift; do not lift the monitor by placing your hand or fingers on the monitor panel.
- Unplug the monitor if you are not going to use it for an extensive period of time.
- Unplug the monitor if you need to clean it with a slightly damp cloth. The screen may be wiped with a dry cloth when the power is off. However, never use organic solvent, such as, alcohol, or ammonia-based liquids to clean your monitor.
- To avoid the risk of shock or permanent damage to the set, do not expose the monitor to dust, rain, water, or excessive moisture environment.
- If your monitor gets wet, wipe it with dry cloth as soon as possible.
- If foreign substance or water gets in your monitor, please turn the power off immediately and disconnect the power cord. Then, remove the foreign substance or water, and send it to the maintenance center.
- Do not store or use the monitor in locations exposed to heat, direct sunlight or extreme cold.







#### Connect to PC

- 5. Plug the power cord of your computer and your monitor into a nearby outlet.
- Connect the USB upstream port on the monitor and the USB port on your computer with a USB cable. The USB downstream port is now ready for any USB device to plug in.


## 3 Resolution notification




# 2.3 Detach the hinge for VESA mounting

Before you start detaching the hinge, please follow the instructions below to avoid any possible damage or injury.


1. Place the monitor face down on a smooth surface. Pay attention not to scratch or damage the screen.




2. Use your fingers to squeeze the hinge cover gently till the hook slip out of the slot.



3. Use a screwdriver to loosen 4 screws.






### 2 Why do I need it?

You want a monitor that delivers optimized display all your favorite types of content, SmartImage software dynamically adjust brightness, contrast, color and sharpness in real time to enhance your monitor viewing experience.

### 3 How does it work?

SmartImage is an exclusive, leading edge Philips technology that analyzes the content displayed on your screen. Based on a scenario you select, SmartImage dynamically enhances the contrast, color saturation and sharpness of images to enhance the contents being displayed - all in real time with the press of a single button.





- 1. Press 🗇 to launch the SmartImage on screen display.
- Keep pressing ▲ or ▼ button to toggle among Text, Office, Photo, Movie, Game, Economy and Off.



- User can enter PIN between 4 and 9 digits numbers only.
- After entering PIN, Accept button takes user to the pop-up dialog box on the following page.
- Minimum minutes set to 5. Slider set to 5 by default.
- Does not require the display be attached to a different host to go into Theft Deterrence mode.

After creating PIN, the Theft Deterrence pane will indicate Theft Deterrence Enabled and provide PIN Options button:

- Theft Deterrence Enabled is displayed.
- Disable Theft Deterrence Mode opens pane screen on next page.
- PIN Options button only available after user creates PIN, button opens secure PIN web site.

### Help menu



## Context Sensitive menu

The Context Sensitive menu is Enabled by default.

- Tune Display Opens the SmartControl Premium control panel.

• SmartImage - Check current settings, Office, Photo, Movie, Game, Economy, Off.

#### Task Tray Menu Enabled

The task tray menu can be displayed by rightclicking on the SmartControl Premium icon from the task tray. Left Click will launch the application.



The task tray has five entries:

- Help Access to User Manual file: Open User Manual file using the default browser window.
- Technical Support displays the tech support page.
- Check for Update takes the user to PDI Landing and checks the user's version against the most current available.
- About Displays detailed reference information: product version, release information, and product name.
- Exit Close SmartControl Premium.

To run SmartControl Premium again either select SmartControl Premium from Program menu, double-click the desktop PC icon or restart the system.



# Task Tray Menu Disabled



# 4. Built-in Webcam with Microphone

### Solution Note

# USB connection between the monitor and PC is required for the webcam to operate.

The webcam allows you to hold interactive video and audio conference calls over the internet. It provides the most convenient and easiest way for Business persons to communicate with other colleagues around the world, saving a lot time and money. Depending on the software used, it also allows you to take photos, share files or use microphone only without enabling webcam. The microphone and activity light are on the side of the webcam on the bezel of the display.




# 4.1 PC system requirements

- Operating system : Microsoft Windows 7, Microsoft Windows Vista, Microsoft Windows XP (SP2), and any other OS whichever support UVC/UAC (USB Video Class compliant / Audio Class compliant) under USB 2.0 standard
- Processor: 1.6GHz or above
- RAM: 512MB (for XP) / 1GB(for Vista and Windows7)
- Hard disk space: minimum 200MB
- USB: USB 2.0 or above, UVC/UAC support

# 4.2 Using the device

Philips monitor with webcam device transmits video and sound data through USB port. It can be enabled by simply connecting your USB cable from your PC to the USB upstream of USB hub on the bottom IO of monitor.



- Connect your USB cable to upstream of USB hub on the bottom IO of monitor from PC side.
- 2. Turn on your PC and make sure your internet connection is working properly.
- Download and enable free online chatting software such as Skype, Internet Messenger, or equivalent. You can also subscribe to dedicated software in case of more sophisticated usage like multi conferencing, etc.
- 4. The webcam is ready to be used for chat or make the phone call through internet service.
- 5. Make the call by following the instruction of the software program.

#### Solution Note

To set up a video call, you must have a reliable Internet connection, an ISP, and software like Internet messenger or video phone call program. Make sure the person that you are calling has compatible video-calling software. The video and audio performance quality depends on the bandwidth available on both ends. The person you are calling must have similar capability of devices and software. 5. MHL (Mobile High-Definition Link)

# 5. MHL (Mobile High-Definition Link)

## 1 What is it?

Mobile High Definition Link (MHL) is a mobile audio/video interface for directly connecting mobile phones and other portable devices to high-definition displays.

An optional MHL cable allows you to simply connect your MHL capable mobile device to this large Philips MHL display, and watch your HD videos come to life with full digital sound.

Now not only you can enjoy your mobile games, photos, movies, or other apps on its big screen, you can simultaneously charge your mobile device so you never run out of power half way.


#### 2 How do I use the MHL function?

To use the MHL function, you need an MHLCertified mobile device. To find a list of MHLcertified devices, visit the official MHL website (http://www.mhlconsortium.org)

You also need a optional MHL certified special cable in order to use this function.

#### 3 How does it work? (how do I connect?)

Connect the optional MHL cable to the mini USB port on the mobile device side, and the [MHL-HDMI] marked port on the monitor side. You are now ready to view the images on your big screen display and operate all function on you the mobile device such as internet surfing, game playing, photo browsing...etc. if your monitor has speaker function, then you will be able to hear accompanying sound too. When the MHL cable is disconnected or the mobile device is turned off, the MHL function will be automatically disabled.



#### Solution Note

- The port marked [MHL-HDMI] is the only port on the monitor that supports the MHL function when the MHL cable is used. Note that the MHL certified cable is different than a standard HDMI cable.
- A mobile device with MHL certification must be purchased separately.
- You may have to manually switch the monitor to MHL-HDMI mode in order to activate the monitor, if you have other devices already working and connected to available inputs.
- This Philips display is MHL certified. However, in case your MHL device does not connect or work correctly, check with your MHL device FAQ or vendor directly for direction. The policy of your device manufacturer may require you to purchase their brand specific MHL cable or adapter in order to work with other brand MHL devices. Note that this is not a fault of this Philips display.

# 6. SmoothTouch

## 1 What is it?

This is a display which uses "Projected capacitive" 10 point touch panel technology. Used with latest OS like Windows 8, it offers you groovy touch gestures like tap, grab, pinch, rotate, zoom, swipe, etc. Your older applications come to life, and now you can fully utilize the new capabilities of touch based applications. 



# 10. Customer care and warranty

# 10.1 Philips' Flat Panel Monitors Pixel Defect Policy

Philips strives to deliver the highest quality products. We use some of the industry's most advanced manufacturing processes and practice stringent quality control. However, pixel or sub pixel defects on the TFT Monitor panels used in flat panel monitors are sometimes unavoidable. No manufacturer can guarantee that all panels will be free from pixel defects, but Philips guarantees that any monitor with an unacceptable number of defects will be repaired or replaced under warranty. This notice explains the different types of pixel defects and defines acceptable defect levels for each type. In order to qualify for repair or replacement under warranty, the number of pixel defects on a TFT Monitor panel must exceed these acceptable levels. For example, no more than 0.0004% of the sub pixels on a monitor may be defective. Furthermore, Philips sets even higher quality standards for certain types or combinations of pixel defects that are more noticeable than others. This policy is valid worldwide.



#### Pixels and Sub pixels


A pixel, or picture element, is composed of three sub pixels in the primary colors of red, green and blue. Many pixels together form an image. When all sub pixels of a pixel are lit, the three colored sub pixels together appear as a single white pixel. When all are dark, the three colored sub pixels together appear as a single black pixel. Other combinations of lit and dark sub pixels appear as single pixels of other colors.

# Types of Pixel Defects


Pixel and sub pixel defects appear on the screen in different ways. There are two categories of pixel defects and several types of sub pixel defects within each category.

# Bright Dot Defects

Bright dot defects appear as pixels or sub pixels that are always lit or 'on'. That is, a bright dot is a sub-pixel that stands out on the screen when the monitor displays a dark pattern. There are the types of bright dot defects.



One lit red, green or blue sub pixel.



Two adjacent lit sub pixels:

- Red + Blue = Purple
- Red + Green = Yellow
- Green + Blue = Cyan (Light Blue)





### Solution Note

A red or blue bright dot must be more than 50 percent brighter than neighboring dots while a green bright dot is 30 percent brighter than neighboring dots.


## Black Dot Defects

Black dot defects appear as pixels or sub pixels that are always dark or 'off'. That is, a dark dot is a sub-pixel that stands out on the screen when the monitor displays a light pattern. These are the types of black dot defects.



### **Proximity of Pixel Defects**

Because pixel and sub pixels defects of the same type that are near to one another may be more noticeable, Philips also specifies tolerances for the proximity of pixel defects.



#### **Pixel Defect Tolerances**

In order to qualify for repair or replacement due to pixel defects during the warranty period, a TFT Monitor panel in a Philips flat panel monitor must have pixel or sub pixel defects exceeding the tolerances listed in the following tables.

# 11.1 Troubleshooting

This page deals with problems that can be corrected by a user. If the problem still persists after you have tried these solutions, contact Philips customer service representative.

#### 1 Common Problems

#### No Picture (Power LED not lit)

- Make sure the power cord is plugged into the power outlet and into the back of the monitor.
- First, ensure that the power button on the front of the monitor is in the OFF position, then press it to the ON position.

#### No Picture (Power LED is White)

- Make sure the computer is turned on.
- Make sure the signal cable is properly connected to your computer.
- Make sure the monitor cable has no bent pins on the connect side. If yes, repair or replace the cable.
- The Energy Saving feature may be activated

#### Screen says



- Make sure the monitor cable is properly connected to your computer. (Also refer to the Quick Start Guide).
- Check to see if the monitor cable has bent pins.
- Make sure the computer is turned on.

#### AUTO button doesn't function

• The auto function is applicable only in VGA-Analog mode. If the result is not satisfactory, you can do manual adjustments via the OSD menu.

### Note

#### The Auto Function is not applicable in DVI-Digital mode as it is not necessary.

#### Visible signs of smoke or sparks

- Do not perform any troubleshooting steps
- Disconnect the monitor from mains power source immediately for safety
- Contact with Philips customer service representative immediately.

# 2 Imaging Problems

#### Image is not centered

- Adjust the image position using the "Auto" function in OSD Main Controls.
- Adjust the image position using the Phase/ Clock of Setup in OSD Main Controls. It is valid only in VGA mode.

#### Image vibrates on the screen

 Check that the signal cable is properly securely connected to the graphics board or PC.

#### Vertical flicker appears



- Adjust the image using the "Auto" function in OSD Main Controls.
- Eliminate the vertical bars using the Phase/ Clock of Setup in OSD Main Controls. It is valid only in VGA mode.

### Horizontal flicker appears

- Adjust the image using the "Auto" function in OSD Main Controls.
- Eliminate the vertical bars using the Phase/ Clock of Setup in OSD Main Controls. It is valid only in VGA mode.

# Image appears blurred, indistinct or too dark

• Adjust the contrast and brightness on On-Screen Display.

# The "power on" light is too strong and is disturbing

 You can adjust "power on" light using the power LED Setup in OSD main Controls. For further assistance, refer to the Consumer Information Centers list and contact Philips customer service representative.

# 11.2 General FAQs

#### Q1: When I install my monitor what should I do if the screen shows 'Cannot display this video mode'?

- Ans.: Recommended resolution for this monitor: 1920x1080@60Hz.
- Unplug all cables, then connect your PC to the monitor that you used previously.
- In the Windows Start Menu, select Settings/ Control Panel. In the Control Panel Window, select the Display icon. Inside the Display Control Panel, select the 'Settings' tab. Under the setting tab, in box labelled 'desktop area', move the sidebar to 1920x1080 pixels.
- Open 'Advanced Properties' and set the Refresh Rate to 60Hz, then click OK.
- Restart your computer and repeat step 2 and 3 to verify that your PC is set at 1920×1080@60Hz.
- Shut down your computer, disconnect your old monitor and reconnect your Philips LCD monitor.
- Turn on your monitor and then turn on your PC.

# Q2: What is the recommended refresh rate for LCD monitor?

- Ans.: Recommended refresh rate in LCD monitors is 60Hz, In case of any disturbance on screen, you can set it up to 75Hz to see if that removes the disturbance.
- Q3: What are the .inf and .icm files on the CD-ROM? How do I install the drivers (.inf and .icm)?
- Ans.: These are the driver files for your monitor. Follow the instructions in your user manual to install the drivers. Your

computer may ask you for monitor drivers (.inf and .icm files) or a driver disk when you first install your monitor. Follow the instructions to insert the (companion CD-ROM) included in this package. Monitor drivers (.inf and .icm files) will be installed automatically.

#### Q4: How do I adjust the resolution?

Ans.: Your video card/graphic driver and monitor together determine the available resolutions. You can select the desired resolution under Windows® Control Panel with the "Display properties".

# Q5: What if I get lost when I am making monitor adjustments via OSD?

Ans.: Simply press the OK button, then select 'Reset' to recall all of the original factory settings.

#### Q6: Is the LCD screen resistant to scratches?

Ans.: In general it is recommended that the panel surface is not subjected to excessive shocks and is protected from sharp or blunt objects. When handling the monitor, make sure that there is no pressure or force applied to the panel surface side. This may affect your warranty conditions.

### Q7: How should I clean the LCD surface?

Ans.: For normal cleaning, use a clean, soft cloth. For extensive cleaning, please use isopropyl alcohol. Do not use other solvents such as ethyl alcohol, ethanol, acetone, hexane, etc.

# Q8: Can I change the color setting of my monitor?

- Ans.: Yes, you can change your color setting through OSD control as the following procedures,
- Press "OK" to show the OSD (On Screen Display) menu

- Press "Down Arrow" to select the option "Color" then press "OK" to enter color setting, there are three settings as below.
  - Color Temperature; With settings in the 6500K range the panel appears "warm, with a red-white color tone", while a 9300K temperature yields "cool, bluewhite toning".
  - 2. sRGB; this is a standard setting for ensuring correct exchange of colors between different device (e.g. digital cameras, monitors, printers, scanners, etc)
  - User Define; the user can choose his/ her preference color setting by adjusting red, green blue color.

### Solution Note

- Ans.: Your LCD monitor works best at its native resolution of 1920x1080@60Hz. For best display, please use this resolution.

Ans.: Recommended refresh rate in LCD monitors is 60 Hz, In case of any disturbance on screen, you can set it up to 75 Hz to see if that removes the disturbance.

# 11.3 SmoothTouch

- Q1: Why is the touch function not available when I touch the display?
- Ans.: Please ensure the supplied USB cable is connected between your computer and the display properly.
- Q2: Does the touch function only exist on the Windows 8 OS?
- Ans.: ANS.:The touch function works only on OS and applications which support touch functions, like Windows 7 and Windows 8.

# Q3: Do I have to install any software to activate the touch functionality?

Ans.: To activate touch functionality, all you have to do is connect USB cable between your computer and the display. You don't have to install any extra software.

#### Q4: Why my touch function is very slow?

Ans.: The touch function response is dependent on the speed of your computer configuration. For example, your computer must be either Windows 7 or Windows 8 certified to ensure minimum requirement for touch function in order to maximize Touch utility.

# Q5: Why my touch response is not smooth enough?

Ans.: You may need to clean the glass surface of the display with proper screen cleaning material from time to time, as the glass tends to pick up dirt from your fingers. Please keep your hands clean and dry before touching the screen to ensure fluid touch operation.
