

# Connecting the antenna or cable



#### If you connect to an antenna

Any DTV programs that are broadcast in your area can be received for free through an antenna connection.

Contact your local content provider or your local electronics retailer if you are unsure about what HDTV programs are available in your area.

Broadcasters are transitioning from analog to digital TV. This means that a given broadcaster can have channels available either in analog or in digital, or both analog and digital at the same time.

The TV produces stereo sound only if a stereo signal is broadcast.

#### If you connect to a cable

When your TV is connected to the cable socket, you might receive free digital and high definition programs (depending on your cable provider). The channel number for digital and high definition channels includes a dot "•". For example, 11.1, 46.30, 108.201. Contact your cable provider for more information.

#### If you connect to a DBS (Direct Broadcast Satellite)

There are two main DBS systems: DirecTV and DishNetwork. These systems require a separate, proprietary set-top box to decode signals and send them to the TV. The set-top box contains a digital TV tuner for receiving off-air digital broadcasts.

Contact your local DBS provider for more information about the connections and the TV channels.



- [Digital Natural Motion] If the input video contains adjacent video frames with inherent motion blur captured by the video camera, [Digital Natural Motion] will interpolate blur and cause streaking artifacts in high motion scenes. - 2 Use ▲/▼ to highlight an option for digital captions, and press OK to select the option.

### Difficulties viewing closed captions on DTV programming

If you have difficulties viewing closed captions on DTV programming, including HDTV, received from your subscription television provider; you should:

- consult any consumer information and manuals/guides on closed captions for DTV programming provided by your subscription television provider;
- ensure that the captioning function on your set-top box, if applicable, is turned on; and,
- ensure that the captioning function on your DTV is turned on.

If you are still unable to view closed captions on DTV programming, you should contact your subscription television provider for assistance.

# Sleeptimer

You can always put your TV in standby mode earlier or reset the sleeptimer during the countdown.

- 1 Press **SLEEP** to set the sleeptimer.
- (Also, you can set the sleeptimer in **[Features]** menu.)



- When autoprogramming is complete, the lowest memorized channel will be displayed.
- **3** Follow the on-screen instructions to complete the installation.

# Weak channel installation

This function lets you add the channels that were not added by the autoprogram due to the receptible condition at the initial setup.

- Press MENU on the remote control and then use ▲/▼/◀/▶ to select [Setup] > [Installation] > [Channels] > [Weak channel installation].
- 2 Use *I*/*▶* to select channel input box, then use *I*/*▼* to select a channel you want to memorize.
- 3 Use </▶ to select [Search], then press OK.
- 4 Display will be changed to **[Store]** from **[Search]** when the channel is found, then press **OK**.
- 5 Press MENU to exit.

### Note

In most cases, digital channels are not broadcast on the RF channel on which they appear on your TV. To add digital channels you need to know the RF channel on which the digital channel is being broadcast. Eg. If there is a digital channel 9.1 which is being broadcast on RF channel 25, you need to enter 25 while performing a weak channel installation. To find out the RF channel on which a particular digital channel is being broadcast, please contact your local service provider. Installing digital channels using **[Weak channel installation]** might not work for direct cable connections and if the digital signal is too weak for the TV to process.







Video input for analog devices such as DVD, camcorder, game console, etc. To be used with audio input.

## (4) Digital audio output jack

Digital audio output to home theaters and other digital audio systems.

## 5 Antenna input jack

Signal input from an antenna, cable or satellite.

## 6 HDMI 1 input jack

## First HDMI in connector.

Digital audio and video input from high definition digital devices such as Blu-ray players.

In addition to normal HDMI functionality, outputs TV audio to an HDMI ARC-compliant device, such as a home theater system. (HDMI 1 only)

## (7) HDMI 2 input jack

Second HDMI in connector.

## (8) HDMI 3 input jack

Third HDMI in connector.

## (9) USB terminal

Data input from USB storage devices only. Do not connect any device to this terminal such as; digital camera, keyboard, mouse, etc.

## (1) Audio input jack for HDMI 4 and PC

- (1) HDMI 4 input jack Fourth HDMI in connector.
- 12 PC input jack

VGA cable connection for PC.



- 5 Use  $\triangleleft/\triangleright$  to select [OK], then press OK.



#### HDMI/DisplayPort Audio Specifics:

- To hear your PC audio from the TV speakers, make sure the default playback device is the HDMI Audio Device and not your computer speakers/soundcard.
- The HDMI Audio device is a child device on your graphics card, which means your graphics card video & HDMI audio drivers need to be up to date and bug free (we have seen many cases where having a bad video driver resulted in no HDMI audio).
- Make the TV the only output device. Sometimes if you extend your desktop to the TV
  or duplicate the desktop with another monitor or your laptop screen, Windows does
  not make the HDMI audio devices as the default audio playback device.

Preamble
